- d. Mr Arthur Baker and Ms Cath Godfrey, two directors appointed by the Australian Publishers Association Limited (APA).
- e. Mr Richard Eccles and Dr Kate Harrison (Chair), directors appointed by the other directors pursuant to Article 35(a).
- f. Mr Jason Eades, director appointed by the other directors pursuant to Article 35(b).
- g. Dr Oliver Watts, a director who is an artist member, elected by the artist members of the Company.
