LICENCE FEES FROM PRIVATE (INDIVIDUALLY LICENSED) EDUCATION INSTITUTIONS: 2023 DISTRIBUTION

BACKGROUND

Copyright Agency has individual licences with more than 1,000 education institutions including commercial colleges, adult education, and independent universities.

Some of the institutions are using our FLEX product (see here) to manage both the 'digital originals' provided with FLEX by participating publishers (listed here), as well as other content that they have access to. We have been using data from FLEX for distribution since 2019.

We receive some fees for New Zealand students of Australian-based institutions, based on a mandate agreement with Copyright Licensing New Zealand (CLNZ).

CHANGES SINCE 2022 DISTRIBUTION

- given the usage data now accumulated from FLEX since 2019, the dataset is made up of titles
 relating to FLEX (in the usage data, and digital originals provided by participating publishers),
 and we are not supplementing this data with 'indicative' data (other titles available for copying
 by sector)
- as a consequence, there is a single pool for publications (rather than separate pools for books, journals, and newspapers/magazines)
- the distributable amount will include unpaid allocations from past distributions of licence fees from this sector that have 'rolled over', that will form part of the Annual Writers Distribution in June 2023
